2. Electronic copies of the Notice of the AGM and the Annual Report for the year 2017-18 have been sent to all the members whose email IDs are registered with Company/Depository Participant. Printed/ hard copy of the same has also been sent in the permitted mode to members at their registered address, whose email id is not registered with Company/Depository Participant. Members holding shares either in physical form or dematerialized form, as on the cut-off date (September 20th, 2018) may cast their vote electronically on the business set forth in the Notice of the AGM through electronic voting systems of the Central Depository Services (India) Ltd. From a place other than venue of the AGM (remote e-voting). All the members are informed that:
 - i. The business as set forth in the Notice of the AGM may be transacted through voting by electronic means;
 - ii. The remote e-voting shall commence on September 24th, 2018 (10.00 a.m. IST);
 - iii. The remote e-voting shall end on September 26th, 2018 (5.00 p.m. IST);
 - iv. The cut-off date for determining the eligibility to vote by electronic means or at the AGM is September 20th, 2018;
 - v. E-Voting shall not be allowed beyond 5.00 p.m. IST on September 26th, 2018;
 - vi. Members may note that; a) The remote e-voting module will be disabled by CDSL beyond 5.00 p.m. IST on September 26th, 2018 and once the vote on a resolution is cast by a member, he/she shall not be allowed to change it subsequently; b) The facility for voting through ballot paper will be made available at the AGM for members present at the meeting; c) The members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again; and d) Only persons whose names are recorded in the register of members or in the register of beneficial owners maintained by the depositories on the cut-off date shall be entitled to vote using the remote e-voting facility or at the AGM using ballot paper;
